- Order 34 issued September 18, 2003
- Commission accepts, with conditions, Chugach's Cost Allocation Manual
 - Generally concurs with Chugach submittal
 - Requires submittal of updated CAM 6 months prior to next rate case
 - Update must reflect agreed-upon changes

Wholesale Customer Activity

- Comments on Order No. 33 Compliance Filing
 - Critical of base fuel cost recovery adjustment process
 - Questions minor (\$1,320) correction of Commission calculation

Chugach Filings

- Response to HEA / MEA comments on Order No. 33 compliance filing
- Petition for reconsideration of Order No. 34 on Cost Allocation Manual

Chugach Filings (Continued)

- Motion to Dissolve Stay
 - Provides immediate implementation of wholesale and retail rates established in Order No. 33
 - Increases revenue by \$0.7 million annually
 - If successful on appeal, foregoes Chugach's ability to adjust potential refunds from Order No. 33 rates to January 31, 2003
