

Seven members run for Chugach board

Seven Chugach members are running for three seats on the cooperative's board of directors in this spring's election. Each seat is for a three-year term. In addition, members will be voting on three proposed bylaw amendments.

The 2005 candidates are H.A. "Red" Boucher, Samuel W. Cason, Alan Christopherson, Patricia B. "Pat" Jasper, Uwe Kalenka, Mark L. Smith and Elizabeth "Liz" Vazquez. Boucher, Cason and Jasper are incumbents.

Boucher, 84, is a self-employed communications consultant with H.A. "Red" Boucher & Associates. He is also president of Alaska Wireless Technology. Boucher has been a Chugach member for 28-1/2 years. He was nominated by the Nominating Committee. Cason, 45, is a self-employed attorney. He has been a Chugach member for 12 years. Cason was nominated by the Nominating Committee. Christopherson, 52, is a civil engineer with PND. He has been a Chugach member for 14 years. Chris-

topherson was nominated by petition. Jasper, 75, is a small-business owner. She has been a Chugach member for 40 years. Jasper was nominated by the Nominating Committee. Kalenka, 60, is a self-employed property manager. He has been a Chugach member for more than 34 years. Kalenka was nominated by petition. Smith, 44, is the General Manager/President of Yukon Fuel Company. He has been a Chugach member for seven years. Smith was nominated by the Nominating Committee. Vazquez, 53, is an attorney with the State of Alaska. She has been a Chugach member for 16 years. Vazquez was nominated by petition.

Mail-voting packets were mailed to 62,380 Chugach members of record the week of March 28 that included an election brochure with meeting announcements, statements and attendance and voting records, a ballot and a return envelope. Members have until noon on April 25 to return mail ballots. Voting will also be allowed at the cooperative's annual meeting, April 28, at the Egan Civic & Convention Center. Results of the election will be announced at the annual meeting.

Message from Chugach


Chugach recently participated in discussions with the Anchorage Assembly on amending the Municipality's underground ordinance. Chugach backed the resulting amendment that updated the 20-year-old ordinance that required new utility construction be placed underground in most instances. The amendment passed by the Assembly in March requires utilities to spend 2 percent of the gross retail revenues on undergrounding existing lines within the Municipality of Anchorage. Chugach members will see this cost as a separate line item on their monthly bills. The amended ordinance also allows the utilities to plan what lines would be buried rather than the Department of Community Planning & Development. Chugach sees these as positive improvements.

Recent articles did not make it clear that transmission or sub-transmission lines would not be buried under this ordinance. In fact, the lines being buried are ones that are a lower distribution voltage.

Other statements have been made saying that underground lines are safer. In reality, Chugach builds all of its facilities to meet or exceed electrical safety requirements. Finally, some of the recent infor-

mation released said that underground lines have a longer life span. Chugach is currently replacing underground lines that were installed in the 70s and 80s due to the significant number of cable failures. Many overhead lines installed more than 60 years ago are still providing reliable power to businesses and homes in our community. No one will argue that underground cable is more pleasing because it is out of sight; however, it does require more maintenance, repair is often more difficult to perform simply because it is underground and not as accessible, particularly during the winter months, and an underground failure can take longer to repair and create a longer outage.

While there are advantages and disadvantages to both underground and overhead electric lines, Chugach does a good job of maintaining all of its facilities in order to provide safe, reliable and competitively priced electrical service for all of its members. Chugach will continue to bury lines in accordance with the undergrounding ordinance as it looks towards the needs of the future. ☺
