Four members run for the Chugach board

Four Chugach members are running for two seats on the cooperative's board of directors in this spring's election. Each seat is for a 3-year term.

The candidates are David J. Cottrell, Alex Gimarc, P. J. Hill and Mark Wiggin. Cottrell is an incumbent.

Electric bills driven by fuel increases


As the accompanying chart shows, for more than a decade, the monthly bills of Chugach customers have been driven by fuel prices.

Natural gas is the primary fuel used to make power at Chuqach power plants. In 2006, 90 percent of the kilowatt-hours Chugach sold were produced by burning natural gas; the other 10 percent came from hydro power.

Chugach buys natural gas from four separate suppliers under four separate contracts - each indexed to changes in three different commodities over a rolling 12-month period of time. Bills rise and fall as the price of the three commodities - natural gas, heating fuel and crude oil

- changes on the national market.

Chugach adjusts the fuel surcharge each quarter to reflect the costs of fuel and purchased power. Beginning in April,

the bill for a residential customer using 700 kwh in a month will drop by \$2.34 due to a decrease in the fuel surcharge.

Members will also be voting on two proposed bylaw amendments.

Mail-voting packets were mailed to 64,348 Chugach members of record the week of March 26. Members have until noon on Monday, April 23 to return mail ballots. Voting will also be

allowed at the cooperative's annual meeting April 26 at the Egan Civic & Convention Center. Registration starts at 6 p.m. The meeting begins at 7 p.m. Members should bring a photo I.D. to the annual meeting to help speed up their registration. Results of the election will be announced at the annual meeting.

2007 overhead-to-underground projects planned

Chugach annually spends about 2 percent of its 3-year average of gross retail revenues derived from sales within the Municipality of Anchorage on overhead to underground conversion projects in Anchorage.

In 2007 Chugach expects to spend about \$2.7 million to complete conversion projects that include:

- a 3-year \$2.25 million project to convert a 3-phase circuit along the east side of Muldoon Road between DeBarr Road and East 32nd and along East 32nd to Patterson Street;
- a 2-year \$1.9 million project on John's Road to retire 14 spans of older 3-phase overhead facilities
- and a 2-year \$1.25 million project

to retire and replace 5,000 feet of line along Jewel Lake Road south of the Raspberry Road intersection.

Chugach currently estimates it will spend nearly \$18 million on conversion projects in the next five years. Projects are selected taking into account Chugach's overall system needs and consideration of designated target areas.

The projects are funded by the 2 percent underground charge on bills for service in Anchorage. The charge is a result of an MOA ordinance adopted March 1, 2005.

2004 Capital credits allocations

In December 2006 Chugach completed allocating more than \$6.4 million in retail and wholesale capital credits for 2004. In March Chugach notified 49,874 current retail members of their share of the allocation on their electric bills, while 19,152 former members were mailed a certificate showing their allocation.

Chugach does not earn profits. Instead, any revenues and other income over and above the cost of doing busi-

ness during a given year are considered "margins" and are returned to members through capital credit retirements that are approved by the Chugach board. Capital credit balances may also be checked on the Chugach web site at www.chugachelectric.com.

Notifying current members by providing their information for them on their bills saved Chugach and its members nearly \$25,000 in postage, printing, materials and mailing costs.
