

Moving forward with ML&P acquisition

Work continues on the acquisition of Municipal Light & Power (ML&P) by Chugach, five months after voters approved the ballot initiative allowing the Municipality of Anchorage (MOA) to sell the utility. In April, 65 percent of Anchorage voters said yes to the acquisition.

Negotiations between Chugach and the MOA are ongoing, and teams have been meeting throughout the summer. As work continues toward finalizing the Asset Purchase Agreement (APA), due diligence is underway, and the teams are meeting regularly.

According to the ballot language approved by voters, the acquisition must be approved by Anchorage

Impacts of lower energy use

According to the Energy Information Administration, historical data shows that there has been a decline in U.S. residential electricity sales in the last few years. This trend is also seen in Southcentral Alaska, and data specifically for Chugach Electric shows that despite increasing numbers of residential members, electricity sales have been declining. Since 2004, the average usage per residential member has dropped 14 percent. While a portion of this difference is attributed to factors such as weather, the primary driver is energy efficiency.

Members are reducing their electric energy use, which reduces their bills. It also reduces the total amount of natural gas used by the utility which translates to a direct reduction in the amount a member pays on their electric bill. The reduced use of fuel decreases the carbon dioxide and other greenhouse gasses emitted from burning natural gas, conserves local natural gas supply, and increases the overall proportion of hydroelectric and wind energy in the system. While the fuel costs may decrease, the costs for infrastructure and operations, shown Assembly ordinance by December 31, 2018. With that in mind, the Chugach Board of Directors and the Assembly have requested the APA be provided to them before the end of October, to allow adequate time for review, public discussion, and approval. Once the Chugach Board and the Assembly approve the final terms, the Regulatory Commission of Alaska will then review the acquisition. If approved,

it is anticipated ML&P employees and members will become part of Chugach in mid-to-late 2019.



as the energy and demand charges on the bill, must still be recovered through rates. The infrastructure and operating costs are divided by the number of kilowatt-hours sold, resulting in a slightly higher rate if less electricity is used by the membership.

In a recent survey, Chugach asked its members if they thought their usage would likely go up, go down, or stay the same in the next three years. Surprisingly, 62.5 percent of members indicated their usage would stay the same, while 19 percent thought their usage would increase. Only 18.5 percent indicated their usage would go down. Only time will tell if members' usage assumptions are correct. Meanwhile, Chugach supports energy efficiency and is here to help members understand their electric energy usage better.
