Commissioners:

This filing requests approval by the Regulatory Commission of Alaska (Commission) of an amendment extending the term of the Isolated Operating Agreement For Government-Owned Disaster Preparedness Generation Facilities (Agreement) between Chugach Electric Association, Inc. and the Anchorage School District (Parties) for an additional one (1) year period.

The Commission previously approved this Special Contract Agreement in Letter Order L0600565 arising out of Tariff Advice No. 275-8. Over the years, the Parties have not experienced any difficulties with the Agreement, and the Agreement continues to confer the intended mutual benefits. Section 8, paragraph 28 of the Agreement allows the Parties to extend the Agreement for an additional 10-year term. At this time, however, the Parties desire to extend the Agreement for a 1-year period to provide the opportunity to work together to update the Agreement which was originally approved by the Commission in 2006. The amendment to the Agreement is included as Attachment A.

In compliance with the Alaska Public Utilities Regulatory Act and 3 AAC 48.200 - 3 AAC 48.430, Chugach hereby submits the following tariff sheet to reflect an additional 1-year term to the Agreement.

This filing is not for a new service and will not result in the termination of an existing service or conflict with any other schedule or rate contained in Chugach's operating tariff. This filing has no impact on Chugach's revenues, and Chugach does not believe that any customer is directly impacted by this filing. Rather, Chugach believes the interconnected electric power system is benefitted by the limited power supply redundancy permitted by this agreement.

Contract Summary

As explained in Commission Staff memorandum dated August 15, 2006 (Tariff Advice 275-8), the Agreement allows:

...ASD to use a very limited section of Chugach's distribution system (within the Service High School Complex) in emergency situations. According to Chugach, it normally prohibits third parties from using its distribution system under any circumstances. Under the contract, emergency situation is narrowly defined as 1) a disaster, or urgent or critical situation of a temporary nature under which ASD is responsible to retain students for their safety within the Service High School Complex and 2) Chugach is not able to provide electrical service from its distribution system. Chugach explains that it recognizes the public benefit of allowing a deviation under this unique situation.

The Commission recently approved a similar special contract between Municipal Light and Power (ML&P) and ASD for limited use of ML&P's distribution systems at Bartlett and West High Schools.² ASD is installing generation facilities at twenty one schools located throughout the Municipality of Anchorage as part of a district wide disaster preparedness effort. It was possible to serve many of the schools with standby generation from a single point on the school campus. However those that have widely separated points of delivery must be connected to an isolated portion of the utility distribution line. The line is then isolated from the grid to allow distribution within the school complexes when the utility experiences a power outage.

The Parties have professionally and effectively cooperated to their mutual benefit so that the Agreement has operated as anticipated and confers the benefits desired by the Anchorage School District while operating successfully with Chugach's system. It is in the interest of the Parties and the public to continue under this Agreement for an additional 1-year period to allow the Parties to work together to update the agreement, now 10 years old.
