Subject: Tariff Advice No. 438-8; Extension of Term – Gas Sale and Purchase Agreement

between Cook Inlet Energy, LLC and Chugach Electric Association, Inc.

Commissioners:

The Regulatory Commission of Alaska (Commission) approved the Gas Sale and Purchase Agreement between Cook Inlet Energy, LLC and Chugach Electric Association, Inc. (Agreement) on November 25, 2013 in Letter Order L1300531. The term of the Agreement extends through March 31, 2018. Section 4.2 of the Agreement provides that the term may be extended by mutual agreement for an additional 5 year period. Chugach Electric Association, Inc. (Chugach) is pleased to notify the Commission that the parties have agreed to extend the Agreement for an additional 5-year term, or through March 31, 2023. Attached is a letter signed by Cook Inlet Energy, LLC and Chugach agreeing to this extension.

In compliance with the Alaska Public Utilities Regulatory Act and 3 AAC 48.200 – 3 AAC 48.430 of the Alaska Administrative Code, Chugach submits updated Tariff Sheet No. 73.5 to reflect the five year extension of the contract, or from March 31, 2018 to March 31, 2023. Tariff Sheet No. 73.5 is Chugach's Schedule of Natural Gas Confirmations.

This filing is not for a new electric service nor will it result in the termination of an existing service or conflict with any other schedule or rate contained in Chugach's operating tariff. Approximately 68,200 retail members (80,950 meters) and the wholesale class of Seward Electric System are impacted by this filing.

Description of Tariff Sheet Changes

Tariff Sheet No. 73.5: This tariff sheet has been modified to reflect the extension of the "Gas Sale and Purchase Agreement between Chugach and Cook Inlet Energy, LLC" to March 31, 2023. Chugach has added the contract extension and the previously agreed-upon gas price for each contract year.
