SUBJECT: Member Advisory Council

Chugach Electric Association, Inc.'s (Chugach) Bylaws provide that the Board of Directors may create and establish a Member Advisory Council (MAC) to advise the Board as an ad hoc committee (Article XIV, Advisory Council, Section 1, Member Advisory Council).

After several years of not having a MAC, in June of 2021, the Board of Directors established a 15-member MAC to begin service in January 2022 for one-year terms. That committee met quarterly in 2022, for a total of four meetings. In the fall of 2022, Chugach advertised for new MAC members to serve in 2023. There were 15 applicants for 15 seats, of which 10 served on the 2022 MAC and reapplied. All 15 applicants were appointed to serve on the 2023 MAC. The 2023 MAC has met three times as of this date and has a fourth and final meeting scheduled for October 4, 2023.

Discussion

The MAC members in both 2022 and 2023 have been excellent participants. They enjoy the meetings, have good questions and feedback, and report a positive experience. Whereas the Bylaws state the MAC is "to advise the Board as an ad hoc committee," the committee has generally operated with topics chosen by the MAC members with educational presentations from Chugach management. Multiple Chugach employees attend the meetings to present topics requested by the MAC, and the presentations made are often similar to presentations made during Chugach's Board meetings.

Over the last two years, the MAC has provided feedback to the Chugach Board on the annual meeting, the member appreciation event, the election process, and beneficial electrification. Several members of the MAC have indicated they would like additional direction from the Board of Directors regarding the MAC's role and purpose.

Recommendation

• It is recommended that Chugach provide additional direction to the MAC for identification of specific topics, goals and objectives for the upcoming year. Alternatively, given the feedback from the MAC on key topics, is it appropriate to consider taking a hiatus until additional information is needed by the Board.

• If the MAC continues in calendar-year 2024, it is recommended that the term for members on the MAC be capped at two years which allows more members to rotate through the council. Additionally, the "learning gap" gets wider between first-time members and those serving multiple years which makes it more difficult to offer presentations that are meaningful to all.

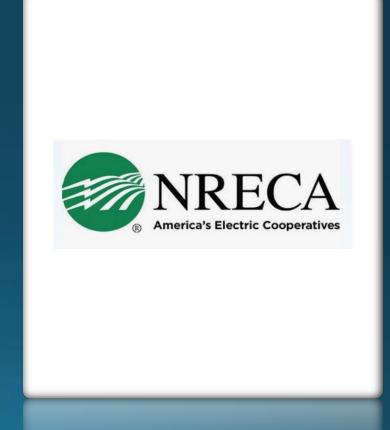
