Appointments to 2023 Member Advisory Council (MAC) Committee

DISCUSSION

Section 1 and 2 of Article XIV of the Chugach Electric Association, Inc. (Chugach or Association) Bylaws provides that the Board of Directors may create and establish a MAC to advise the Board as an ad hoc committee. It shall be the duty of the Board of Directors to appoint members to the advisory council as provided in Article XV. Members shall be selected from different sections of the service area of the Association to provide broad representation.

The deadline for 2023 applications was 5:00 p.m. on Thursday, September 29, 2022. Chugach ran advertisements for MAC volunteers in the Anchorage Daily News beginning September 4 and ending September 28 in the Sunday and Wednesday editions, for a total of eight times.
