

Chugach & ML&P to explore potential merger or other relationship

Chugach Board Chair Elizabeth Vazquez and Mayor Mark Begich signed an agreement June 15 aimed at leading to a decision by this fall on whether it makes legal and financial sense for Chugach and Anchorage Municipal Light & Power to merge or somehow combine operations. The two agreed to appoint a panel of experts to help analyze the possibility of a single utility pursuant to the detailed five principles the two utilities will follow as discussions continue.

"The interests of the people and businesses of Anchorage should take priority in all these discussions and decisions," Vazquez said. "After all they are the owners of these utilities, as taxpayers and/or as co-op members. What we're after is the lowest cost possible for the customers."

"Through this process, we hope to improve service to customers and stabilize rates by increasing efficiencies and eliminating duplication," said Begich. "I'm pleased the management of both Chugach and ML&P are now open to this new era of cooperation."

At issue is how to provide affordable electricity to residents and businesses in the Anchorage bowl. When initially formed, ML&P was envisioned as the provider to urban residents while Chugach would meet rural needs. Over time, those distinctions have blurred, with ML&P largely serving downtown, Chugach serving most of the rest of Anchorage and Matanuska Electric Association serving from Eagle River north.

For several weeks, Chugach board members and Begich have discussed the possibility of joint operations. An oversight team will be appointed to help direct the analysis, including a former member of the Regulatory Commission of Alaska, a Chugach board member, a member of

the Anchorage Assembly, an ML&P official and a Chugach ratepayer. The team will be co-chaired by Vazquez and Begich.

The two identified five principles under which the team will work, including:

- Ensure the greatest benefit for the existing ratepayers of the two utilities.
- Eliminate duplication of services.

- Increase efficiency of services.
- Create rate stability for current and future ratepayers.
- Maximize asset value for owners of both companies.

Officials from both sides have agreed not to pre-judge the outcome, and they could even decide not to pursue a merger or joint operations if the analyses determines it makes little sense.

Statement of Principles

Chugach Board Chair Elizabeth Vazquez and Mayor Mark Begich signed the following Statement of Principles in exploring a potential merger or other relationship of the utilities:

1. Ensure the greatest benefit for the existing ratepayers of the two utilities. The interests of the people and businesses of Anchorage should take priority in all decisions concerning a potential merger or other form of relationship and the structure of the final entity. Other important interests to be valued and balanced as well include those of the utilities' owners (as taxpayers and/or as co-op members), and of the employees of the two utilities.

2. Eliminate duplication of services. The existing organization of electric utilities in Anchorage developed at a time when ML&P served urban consumers and Chugach served rural consumers. In today's Anchorage, the distinction between the two service areas is no longer meaningful. However, the duplicated structure of the two utilities remains. A primary goal of a merger or other form of relationship is to eliminate this duplication and serve all of An-

chorage with a single, rationally integrated company.

3. Increase efficiency of services. We believe that the unification of ownership and direction of electric utility assets in Anchorage will likely create new managerial, financial and operational efficiencies which will maximize the future organization's ability to implement the most efficient solutions for electricity users in Anchorage as a whole.

4. Create rate stability for current and future ratepayers. Low, stable electrical rates are a key component of economic growth. This benefit may outweigh all other benefits attained by the citizen-owners of our utilities. A merger or other form of relationship should be designed to keep rates as low and as stable as possible.

5. Maximize asset value for owners of both companies. ML&P and Chugach represent decades of investment by residents of Anchorage in the utility companies they own. The value of these investments must be recognized.
