rees enhance the beauty of our lives and provide many benefits, including shade, privacy and cleaner air. When planting a tree, remember to carefully select the planting site. Avoid planting trees beneath or adjacent to overhead utilities. Trees contacting overhead power lines are unsafe and cause power outages. Locate trees away from underground utilities as well and call the Locate Call Center at 278-3121 for utility locates before digging. It can be costly to remove or prune trees planted in conflict with utilities, but with a little planning these costs can be eliminated.

## **Outage Highlights Need** for South Anchorage Substation

hen a goose got into the 34.5-kilovolt system at Chugach's . University Substation on the morning of May 29, the resulting outage affected approximately 30,000 customers served by seven neighborhood substations.

The 34.5-kv system is the link in the power grid that feeds power from a bulk power substation to neighborhood distribution substations. One reason so many customers lost power is that Chugach has only two bulk power substations in the Anchorage Bowl. Together, Chugach's University Substation in East Anchorage and International Substation in West Anchorage feed power to 18 neighborhood substations that serve customers across the Bowl.

Chugach has purchased land for a new bulk power substation in South Anchorage and is currently working on plans to build a new 138-kv transmission line to energize it. Once the new facility is built, Chugach will be able to reduce the load carried by any one bulk power substation and the number of customers affected by a disruption like the goosecaused outage.

#### hugach's 2003 annual meeting and election


were held April 24 and incumbents Chris Birch and Jeff Lipscomb were re-elected to three-year terms on the board. The membership also voted to pass the three proposed bylaw amendments that dealt with board and staff titles, bonds of officers and director compensation.

Two hundred eight members registered for the meeting that drew a crowd of about 450 people. A total of 13.8 percent of the 60,656 eligible members voted in the 2003 election.

Immediately following the annual meeting the board met to elect officers. For the coming year Bruce Davison will serve as the Chairman of the board, H.A. "Red" Boucher as Vice Chair, Patricia B. "Pat" Jasper as Secretary and Jeff Lipscomb as Treasurer.
