Chugach & AFD remove dead and dying trees in Turnagain Arm communities

Chugach and the Anchorage Fire Department have continued a partnership started in 2005 to remove dead and dying trees in the Municipality of Anchorage. The trees – most often beetle-killed spruce – are classified as "danger trees" that put the electric system at risk and provide a fuel source for wildfires. The work this year – in the Bird and Indian areas – follows similar efforts by the two organizations in the Municipality over the past two years.

"Danger trees" are located outside of Chugach's rights of

way. They are considered a danger because they have the potential to fall on a power line and cause an outage. Chugach regularly clears its rights of way and has an ongoing in-house program to cut danger trees. Under its own program, with the permission of property owners Chugach drops danger trees safely to the ground and leaves them for the landowner. The AFD-federally funded work goes a step further and pays for Chugach's contractor to remove the downed trees from the property. This year, because of the size of the trees, most of

them must be climbed and removed piece by piece.

"It's a win-win situation for everyone," said Chris O'Brien, Chugach's Arborist. "The Fire Department wins because we're reducing the fuel load throughout the Municipality. Chugach wins because we're removing danger trees that would have a high probability of hitting the power lines and we're reducing the fuel load

around the power facilities. And it's a win for the homeowner

Bright idea for saving energy

Making improvements to your lighting is one of the fastest ways to cut your energy bills. An average household dedicates 5-10 percent of its energy budget to lighting.

Compact fluorescent lighting provides bright, warm light while it requires 2/3 less energy than standard incandescent



lighting, generates 70% less heat, and lasts up to 10 times longer. Although compact fluorescent lamps cost a bit more than incandescent bulbs, they pay for themselves by saving energy over their lifetime.

According to the U.S. Department of Energy, if every American home replaced just one incandescent light bulb with a compact fluorescent light bulb, we would save enough energy to light more than 3 million homes for a year, more than \$600 million in annual energy costs, and prevent greenhouse gases equivalent to the emissions of more than 800,000 cars.

'LEEP' program to focus on business lighting efficiency

At its Aug. 22 meeting, the Operations Committee recommended the Board approve Chugach becoming an official Utility Partner in an energy-efficiency initiative targeting business lighting. The program, sponsored by Green Star is called the Lighting Energy Efficiency Pledge (or "LEEP"). It will kick off an 18-month effort in October.

LEEP will focus on business lighting - which Green Star says is the most cost effective and easiest way to achieve energy efficiency gains. The organization says retrofitting lighting to today's more advanced and efficient technolo-

gies can typically save a business between 25 and 50 percent of their lighting bill.

The Chugach Board of Directors will consider the issue at its meeting on Sept. 19.

Chugach/ML&P study update

Efforts continue in the ongoing study into whether there are benefits to be gained for customers by the consolidation, reorganization, merger or some other coordination of activities between Chugach and Anchorage Municipal Light & Power.

Recent activity includes the following actions:

- Representatives of Chugach and ML&P have been meeting with Navigant, the lead consultant on the study, to provide information necessary for the study.
- The Chugach Board selected legal counsel to provide advice on bond and debt issues

with regard to the study.

- Don May, a former utility commissioner and a consultant on utility issues, was appointed to fill a vacancy on the study's advisory committee created by the resignation of one its original members.
- The committee has scheduled its second meeting for 1:30-3:00 p.m. on Sept. 6 in the Mayor's conference room. Ron Nichols of Navigant will present a status report on the consultant's analysis. The public is invited to attend.

Your Board is charged with the management of the business and the affairs of the Association. Recent Board activity included:

- Adopting the 2008 Budget and Capital Improvement Program quidance using specific financial targets.
- Selecting legal counsel to advise on bond and tax issues during the Chugach/ML&P possible reorganization study.
- Approving refinancing a \$5 million note with CoBank at the most attractive rate available. The note was originally issued in 1997.

- Approving a \$2.2 million project to protect the Sixmile West 230-kilovolt submarine cable terminal from erosion.
- Approving a Drug & Alcohol Policy and Procedures that sets limits and steps for evaluations - including random testing.
- The Finance Committee recommended the Board approve a payment system for credit cards whereby the members who use credit cards pay the costs associated with processing their payments for an eventual annual savings of \$820,000.

because they benefit from having hazardous trees removed from their property, plus they get the benefit of a clear, defensible space in the event of a fire."



> total of 289 permits for new construction and Chuqach had connected 340 new services, compared to 460 permits and 681 new services at the same point in 2006.



Power lines and vehicle safety

If you're in a vehicle accident involving power lines or facilities, the safest place for you to be is in the car. Power company employees will determine when the lines or equipment have been de-energized and tell you when to exit the vehicle.

If the car is on fire and you must get out, jump out with both feet together and hop away from the vehicle. (This prevents the hazard of "step potential" from varying

voltage levels in the ground.) Do not touch the car and the ground at the same time as you could provide a path to the ground for the electricity, causing an injury or fatality.
