Chugach urges Yes vote on consolidation - Proposition 10

Chugach Electric is urging members to vote yes on whether the city should move forward with the consolidation of Chugach Electric and Municipal Light and Power. The question is on the municipal election ballot as Proposition 10, asking voters to authorize the Municipality of Anchorage (MOA) to sell ML&P to Chugach.

Consolidating Chugach and ML&P has been discussed in Anchorage for more than 30 years, with the goal of eliminating duplication and taking advantage of the economies of scale that can be realized when you have one utility serving the small population of the Anchorage Bowl.

As part of its offer to the MOA, Chugach says potential savings of hundreds of millions of dollars will be realized over several decades, reducing electric rates for all ratepayers in the long-term. If voters approve the sale, further due diligence work will be done to reach a final sales agreement. That agreement needs to be approved by the Chugach Board of Directors, the Anchorage Assembly, and the Regulatory Commission of Alaska. These meetings are public and Anchorage residents will have a chance to weigh in. Electron Village update



Chugach is continuing to develop the community solar program in which members will be able to enroll to receive a share of the solar power generated by a 500 kilowatt solar project to be built on Chugach property.

The community solar program is a simple way for any member to experience solar power without needing to install it on their roof. Many members rent, own condos, or have roof orientations that are not conducive to solar. This program is designed with them in mind to give equal access to solar energy. Participation in the solar project is more expensive than power today, but it provides members with a direct and simple way to use local renewable energy and reduce their carbon footprint. Participation is optional.

To be notified when shares go on sale and other project highlights, members may sign up at chugachelectric.com/solar. Enrollment is expected to begin in April, pending RCA approval. The project will be constructed once 80 percent of the 500 shares are sold.
