***Subject: Tariff Advice No. 586-8; Chugach Electric Association, Inc.'s Electric Reliability Organization Surcharge for Rates Effective February 1, 2026***

Commissioners:

The tariff filing described below is transmitted to you for filing in compliance with the Alaska Public Utilities Regulatory Act and Sections 3 AAC 48.200 – 3 AAC 48.430 of the Alaska Administrative Code. In accordance with 3 AAC 46.420(e)-(f), Chugach Electric Association, Inc. (Chugach) implemented the Electric Reliability Organization (ERO) surcharge on member bills effective June 1, 2023. Through this filing, Chugach is proposing to update the ERO surcharge and is requesting approval from the Regulatory Commission of Alaska (Commission) of the tariff sheet submitted herein.

With this filing, Chugach is proposing to update the ERO surcharge, a pass-through surcharge on retail member bills, to recover Chugach's costs associated with the Railbelt Reliability Council's (RRC) updated 2026 surcharge as filed under Docket TE10-9001. Chugach's proposed update will increase the ERO surcharge from \$0.00063 to \$0.00069 per kWh. The proposed ERO surcharge update will increase the monthly bill for an average residential member using 525 kWh per month by approximately \$0.03, or 0.02 percent. With this filing, Chugach is submitting this tariff sheet and respectfully requests the Commission to accept the proposed update and approve implementation of the updated ERO surcharge effective February 1, 2026.

This filing is not for a new service, will not result in the termination of an existing service, conflict with any other schedule or rate contained in Chugach's operating tariff, or in any other way adversely impact members or the public. Chugach provides electric service to approximately 90,000 retail members with 113,000 retail metered locations and one wholesale customer, the City of Seward d/b/a Seward Electric System. Chugach is projecting annual revenues of approximately \$394.3 million for the calendar year 2026.

## **Background**

The ERO is a statutorily created entity responsible for developing and enforcing reliability standards as well as conducting integrated resource planning for the Railbelt. Pursuant to AS 42.05.760(e), the Commission issued Order No. E-22-001(12)<sup>1</sup> approving the RRC's application to serve as the certificated ERO for the Railbelt.

On December 31, 2025, the Commission issued Order No. L2500366, accepting the proposed 2026 budget, and setting Chugach's share of the RRC's load serving entities (LSE) surcharge to \$107,618.29 per month, effective January 1, 2026.<sup>2</sup> This revised surcharge will remain in effect on a permanent basis until further adjustments are approved by the Commission.

## **ERO Surcharge Update**

Chugach's ERO surcharge is applied to member bills based on their monthly energy usage and is treated as a pass-through charge. The ERO surcharge update proposed with this filing reflects Chugach's LSE share of the RRC surcharge billings, on or after January 1, 2025, as adjusted by Chugach's projected balancing account balance through January 31, 2026. Chugach collects no more and no less than the amount paid to the RRC and tracks any over or under-recovery through balancing accounts, which are addressed through periodic rate adjustments. Chugach will continue to update its ERO surcharge to members following any approved RRC surcharge revisions. Additionally, Chugach reserves the right to adjust its ERO surcharge as needed to account for over and under recovery, or other conditions requiring an adjustment.

The ERO surcharge is updated to reflect Chugach's LSE share of the surcharge filed under Tariff Advice No. TE10-9001 and approved by the Commission on December 31, 2025, in Order No. L2500366 as shown on Exhibit 4. Chugach's share is adjusted by the projected balancing account balance and allocated based on the projected energy (kWh) sales levels. The ERO surcharge calculation is shown on Exhibit 1, with the monthly balancing account balances and sales levels presented in Exhibits 2 through 3.

## **Explanation of Tariff Sheet**

***Tariff Sheet No. 102.1:*** This sheet provides background information to explain the function of the ERO, the applicability of the ERO surcharge to Chugach's retail members, and the proposed ERO surcharge billing factor for rates effective February 1, 2026.

## **Supporting Exhibits and Attachment**

***Exhibit 1*** shows the calculation of the ERO surcharge factor to be applied to member bills for recovery.

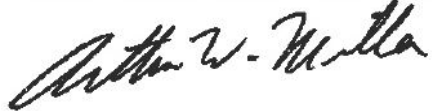

### Electric Reliability Organization Surcharge

The electric reliability organization (ERO) is a statutorily created entity that is responsible for developing and enforcing reliability standards and transmission interconnection standards as well as conducting integrated resource planning for the Railbelt electric system. The ERO recovers its costs associated with those activities from load serving entities (LSE) like Chugach that are located within an interconnected bulk-electric system served by the ERO. Any LSE that is subject to the ERO cost-recovery surcharge may also implement a separate charge on its bills to retail customers to recover costs it incurs through payment of the ERO's surcharge. This tariff sheet contains the terms, conditions, and charges associated with Chugach's recovery of the ERO related costs described above.

#### A. Applicability

The ERO surcharge is applicable to Chugach Retail Members

#### B. ERO Surcharge Balance Account

Chugach shall maintain a balancing account to reflect its LSE share of allocated costs and the amounts recovered through the surcharge. The balancing account reflects the sum of the debit and credit entries described as follows:

- 1) A debit entry equal to the actual total ERO costs for each month of the prior year:
- 2) A credit equal to the surcharge collected from Members by the Association each month of the prior year;
- 3) Debit or credit entries for relevant adjustments and accrual/reversals for entries described in (1) and (2) above for prior period(s).

#### C. ERO Surcharge

The surcharge rate will be adjusted annually to reflect changes in the cost allocation amount as adjusted by balancing account balances and divided by projected retail sales for the recovery period. Chugach reserves the right to revise the rate more frequently if necessary.
